Suggestions:

Tutoring with incentives – Title I schools have tutoring with transportation, all schools provide afterschool tutoring. Find out when each school will provide afterschool activities.

Middle school students tutor elementary school students – Students will need to be driven, walk to schools what have afterschool programs and transportation.

Continue with BYOL – Many parents did not give their child an opportunity to select own books. Students that didn't use their vouchers (\$1200 in vouches) where given books that were purchase for them.

Plan:

Instead, use B&N or Amazon to purchase learning material (curriculum, activity books) to students in need of remediation. Determine students that in lowest 33% in reading to provide curriculum. Determine students that in lowest 33% in math to provide curriculum. Parents will sign an agreement to provide support to complete the curriculum. Student finishing the curriculum will receive an incentive in May. Verification will be the completed curriculum determined by NAP staff. Incentive will be a \$20 voucher to B&N or a selected game.
